Unbundled legal services are now being offered in virtually every state and every community. This chapter provides a broad overview of the many innovative and successful models in operation as of early 2017. The intent is not to provide an exhaustive directory, but to present a wide range of options for you to consider as you think about what model or models might work for your own practice and to accelerate your entry into this exciting field.

We have organized the chapter using the following categories:

- 1. Individual and small law firms that offer unbundled legal services along with full service legal representation;
- 2. Private firms that offer unbundling legal services as a stand-alone service option;
- 3. Nonprofit organizations that offer unbundled legal services;
- 4. Court programs; and
- 5. Bar association programs.

Can you help with parts of my case rather than representing me fully? Yes, oftentimes we represent clients on an "unbundled" basis rather than representing them in all aspects of their case. For example, a client might ask us to limit our representation to the review of an opposing party's settlement offer, the drafting of a difficult document, or the preparation of written materials for a motion. We have a few rules for these types of unbundled services. First, we will not appear in court (orally argue a matter in the courtroom) if we have not prepared the written materials for the court appearance. Second, we will not appear at trial (represent a client in person at trial) if we have not prepared the case for trial. Third, we reserve the right to refuse a request for unbundled legal work if we believe the unbundled services would jeopardize the client's case.

What we now refer to as "unbundled services" also has a more formal name: limited legal services representation. Another suitable description might be legal services "a la carte." Just as this suggests, a lawyer may be engaged to provide a specific and limited kind of help, such as the drafting or review of a proposed agreement, behind the scenes "coaching" for a hearing or mediation, or other limited services consistent with a client's defined needs and budget. With unbundling, client and attorney can define and limit both services and cost in advance in a way that satisfies the needs of both.

Benefits of Using Unbundled Legal Services

Something of value is at risk in any legal dispute. The stakes can be high. It is possible to make mistakes that can be costly to repair. Individuals who try to handle the complexities of their own divorce, without the help of a lawyer, run the risk of overlooking factors that a lawyer would find significant. On the other hand, some people prefer unbundled legal services, either due to the financial cost, or because they prefer to manage the case themselves.

"Unbundled legal services" is a way for you as the client to tailor your investment in a lawyer according to your own resources and your sense of what the situation requires. You and your lawyer will both want to carefully ()

define your respective responsibilities, so that the expectations are set up front, and in the end, everything gets done well.

Unbundled Legal Services versus Traditional Attorney Representation

Traditional attorney representation in a divorce action, for example, includes communicating with the client, advising the client as to legal rights and responsibilities, preparing appropriate pleadings, engaging in adequate discovery, communicating with the opposing party (or counsel), analyzing facts as the facts become known, negotiating on the client's behalf, and appearing and advocating in court for the client. For a continuous period of time, perhaps longer than a year, your lawyer is authorized to speak and act for you in your legal action.

When a prospective client meets with an attorney for an initial consultation, provides information, receives legal advice, and decides not to return to hire the attorney to represent them but instead to represent himself or herself thereafter, that consultation is an example of an unbundled legal service. Other examples of "unbundling" include hiring the attorney for further advice from time to time; hiring the attorney to do specific legal research and provide them with the results; hiring the attorney to review pleadings or to help draft pleadings; hiring the attorney to review a proposed settlement; or hiring the attorney to provide full representation on one of several issues but not any of the others.

Virtual Courthouse is a web-based combination of multimedia technologies and business processes, integrated with a customer-friendly user interface. Our system replicates the current process of dispute resolution in an online environment, removing the constraints of time, expense, and distance.

Couples who are contemplating separation and interested in negotiating cooperatively will pay a flat fee for a two-hour consultation in which a family, financial, and legal professional will provide information about issues that their particular family may need to address in their separation.

The family professional (Sheila Brown, a Registered Social Worker and Accredited Mediator) will provide information on potential parenting and communication issues. The financial professional (Alison Anderson, a Certified Financial Planner accredited as a Financial Divorce Specialist and a Registered Retirement Consultant) will provide information about the financial implications of separation, and I (a family lawyer also trained in Collaborative Practice and Mediation) will provide information about how the law applies and the importance of negotiating durable agreements. Importantly, the couple would hear the same basic information (not advice) at the same time.

The information will be based on the experience of all three professionals. We have been working with separating families for a number of years and have often been retained to work together on collaborative files. No professional will continue on with the couple's resolution process unless retained as a neutral; hence our service is to be called "The Neutral Zone." For me as a lawyer, that means that I could only be retained as a mediator and would not be representing either party in their negotiations.

To the best of my knowledge, while a few professionals (not many lawyers) may provide some information to both spouses, currently no one is offering what we are—in Canada or in the United States. We are designing this to be a cost-effective option for couples who want to get basic information about the steps and potential issues they will face in going through a separation. They will leave with ideas about next steps and in a better position to decide what negotiation option may work best for their family—whether that is mediation, collaborative practice, or perhaps more traditional lawyer to lawyer negotiations.

Although some people have yet to understand what preventive law is, we quote the words of Louis Brown (the Father of Preventive Law), taken from his book, *Lawyering Through Life: The Origin of Preventive Law* (1986):

In preventive law, we seek to prevent legal problems; we also try to identify legal opportunities and develop methods so that people become aware of benefits in time to take advantage of them.

The Community Advocacy Center's Preventive Law Program operates by implementing the following services:

Levitt & Quinn's attorneys practice in key areas of family law, including adoption, child support or spousal support, custody, visitation, domestic violence, marital dissolution, paternity, and probate guardianship. Each year Levitt & Quinn receives more than 6,000 inquires, provides legal information and services to more than 1,700 families, accepts more than 800 clients for representation, and makes hundreds of court appearances on behalf of those clients. California law provides a means for the victims of domestic violence to seek protection through the issuance of a court restraining order. However, most victims of domestic violence require legal assistance to pursue this remedy, but cannot financially afford the cost. The Los Angeles Superior Court's Domestic Violence Clinic was initially piloted in its Southeast District in 1989 and has since been implemented in eight other districts to provide these victims with legal assistance free of charge. The program utilizes student interns and pro bono lawyers, referred by local bar associations, to assist victims in preparation for court hearings and completion of court orders following the hearings. By providing a sympathetic, though objective setting, victims of domestic violence face a less stressful experience upon their arrival at the courthouse.

Materials are available for family and juvenile law, domestic violence, elder law, and landlord/tenant matters. The Self Help Center also provides specialized software that assists in filling out forms, maintains and sells packets for civil court actions, provides notary services, and processes copy requests. The Clerk of the Court Self Help Center is a collaborative effort between the Clerk of the Circuit Court, the Sixth Judicial Circuit, the Community Law Program, and the Clearwater Bar Association and services are available at three different locations.

• Self Help Center Workstations: Self Help Center Workstations are available in all county courthouses except Hennepin and Ramsey. Each workstation has a computer, phone, and printer. You may visit the workstation to find legal information, print court forms, access tools to help you complete court forms, and talk with Self Help Center staff over the phone.

- Walk-In Self Help Center Locations: Some courts have walk-in Self Help Centers where you can receive help in person. Before visiting a walk-in location:
 - Visit Help Topics. You may be able to find the information you need without coming to a center in person.
 - Arrange for child care. The Self Help Centers do not have a play area or toys for children. You and other people using the center will need to be able to focus on legal issues without distraction.
 - Expect to spend some time on your legal issues, both on your own and at the Self Help Center. You may not be able to take care of your legal problem in one visit.

Court staff is ready to help you in whatever way they can. Their role is to provide you with information, not legal advice. They have been instructed not to answer questions if they do not know the answer and may refer you to other resources to assist you in getting the information you need.

- They can give you information on a court case, unless it is not available by law.
- They can give you general information on court rules, procedures, and practices.
- They cannot tell you what to say in court.
- They cannot tell you what a judge might do.
- They can give you court-approved forms (forms might not be available for all legal problems).
- They can explain how to fill out forms for Conciliation Court, domestic abuse, and harassment cases. Note: Some courts offer self-help services and have staff who can explain how to fill out other types of court forms. Visit the Self Help Centers Help Topics for more information.
- They can give you court calendars and information on how to schedule a hearing.
- They cannot give you advice about whether you should file a case or whether you should take any particular action in a case.
- They cannot collect a judgment for you.
- They cannot serve (deliver) your papers for you.

The Civil Law Self Help Center opened in December 2009. The center's mission is to increase informed access to the legal system by providing education, information, legal forms, community referrals, and other support services to self-represented parties with civil matters in Clark County, Nevada, regardless of income, assets, or citizenship. The center was developed through a partnership between the courts in Clark County, Legal Aid Center of Southern Nevada, and the Clark County Neighborhood Justice Center (a free mediation service provided by Clark County). The center is operated and staffed through a contract with the Legal Aid Center of Southern Nevada.

What We Do (and Don't Do)

Among other things, the center

- Provides legal information, educational materials, and training to selfrepresented litigants regarding court rules, court procedure, and various civil legal topics;
- Assists with the identification and completion of legal forms;
- Refers parties to other legal and non-legal community resources;
- Conducts a weekly Ask-A-Lawyer program, at which litigants can meet with volunteer pro bono attorneys regarding landlord-tenant issues; and
- Provides forms and information via its website on such topics as mediation, small claims actions, landlord-tenant disputes, protection orders, and how to represent oneself in court, among other things.

The staff at the center is prohibited from providing legal advice. The staff cannot tell you whether or not you should sue someone, recommend any specific attorney or law firm, give you an opinion about your case or predict how a judge might rule, talk to a judge on your behalf, or tell you what words to use in your court papers or at a court hearing. The staff at the Self Help Center is also obligated to remain neutral. There is no attorney-client privilege or confidentiality of any information shared by a visitor at the center.

Callers unable to afford attorneys' fees are guided toward community pro bono services or to attorneys on the national award-winning LRIS Modest Means program. Through the Modest Means program, residents of Orange County who are unable to afford legal assistance, but do not meet the eligibility requirements of local pro bono services, are referred to attorneys who agree to assist them at substantially reduced rates. The Modest Means program covers the areas of bankruptcy, consumer law, elder law, family law, housing (landlord-tenant), and immigration. There is a \$25 administrative fee, except for the area of family law. Clients must meet specific income guidelines to qualify. An LRIS representative will do a brief screening by telephone. Attorneys may require you to complete a form and attach income verification to confirm eligibility.

The Community Justice Program (CJP) is the pro bono project of the San Antonio Bar Association and is a 501(c)(3) nonprofit organization. It was started in October 2002 and has served more than 8,000 clients. The program collaborates with numerous organizations in the San Antonio area to provide free legal services to indigent and low-income individuals who may not otherwise have access to the legal system. All services are generously provided by volunteer attorneys and staff at legal clinics around the city. The CJP is a proud recipient of numerous awards and honors, including the American Bar Association's Harrison Tweed Award.

The mission of the Community Justice Program is to support legal representation for indigent and low-income residents of San Antonio, but a closely related purpose is to provide local attorneys with the opportunity to engage in pro bono work within a comprehensive and efficient clinic setting. Family Law Court Program

Metro Volunteer Lawyers' Family Law Court Program (FLCP) was created to address a high volume of uncomplicated, uncontested divorce or custody matters, where the other party is not represented by an attorney. FLCP clients represent themselves, appearing pro se, but are assisted through the process by Metro Volunteer Lawyers (MVL). Approximately five times a month in five different counties, clients are invited to the first stage of FLCP, where they complete all the legal documents required to initiate their family law cases. Client groups typically range from 5–20 in a given day. Clinics take place each month in Douglas, Denver, Adams, Arapahoe, and Jefferson Counties. The cases are then filed by our FLCP coordinator, who also arranges for service of process and any additional motion or filings. The last stage of FLCP includes arranging for volunteer attorneys to represent clients in a limited appearance for an uncontested permanent orders hearing on a set day each month in each of the respective counties where MVL provides service.

Post Decree Clinic

The Post Decree Clinic provides unbundled legal services to low-income clients with child custody, child support, and maintenance matters. Clients meet with a volunteer attorney who will give legal advice, assist with drafting appropriate court motions and forms, and give guidance on the next steps in their case, including preparing for any upcoming hearings. The Post Decree Clinic occurs monthly in Denver and Jefferson Counties and every two months in Arapahoe and Adams Counties. Those interested must first contact Colorado Legal Services at (303) 837-1321. Colorado Legal Services will conduct an intake and refer post decree cases to MVL for the Post Decree Clinic.

In addition, we have a Modest Means Task Force that sponsors an Unbundled Roadshow. This roadshow travels around the state presenting to local bars, judicial conferences, section meetings, the Colorado Women's Bar Association, etc. on unbundling. The task force also has submitted surveys to the Family Law Section on how many lawyers use unbundling. The task force is also piloting an ask-a-lawyer clinic at Denver DR Self-Help Center that provides consultation.

CONCLUSION

Many other firms and organizations offer unbundled services, some of which (such as the Volunteer Lawyer Network in Minneapolis) are featured elsewhere in this book (see Chapter 15). Some courts and bar associations maintain rosters of local attorneys that offer unbundled services. Over two decades ago, the Maricopa County, Arizona Superior Court, under the leadership of

Judge Rebecca Albrecht, partnered with the Maricopa Bar Association to train lawyers in unbundled services and provide the public with a list of trained attorneys and their hourly rates. In 2016, Iowa and Maryland each offered a full day's MCLE program on unbundling to train lawyers to expand legal access. It is our hope that one or more of the models described in this chapter will be an inspiration for you to incorporate unbundling in your practice and to work with courts and other local organization to make unbundled legal services a common and accessible option in your community.

For more information on how to become involved in a court or nonprofit program, a good first step is to reach out to one in your area that appeals to you. If you want more information on unbundling in practice and implementation, reach out to firms that are doing it successfully. You do not have to reinvent the wheel. Many, if not most, of these programs are replicable in your community if you have the leadership and support of your local family law bench, bar association, and other community organizations and stakeholders.
